



CONTEST RULES AND REGULATIONS

1 – HATCHIMAL

1. Contest entries close at 9 pm on Thursday, December 15th, 2016. The Winner will be notified Tuesday, December 20th, 2016.
2. **The contest is open to any Canadian citizen or landed immigrant residing in Canada with the exception of owners, employees, their immediate families, and persons with whom they are domiciled, of Westshore Town Centre stores, Bentall LP, and any other organizations, media, or businesses, which assist or aid in the contest.**
